**MEMORANDUM OF UNDERSTANDING
BETWEEN
HI-TECH MEDICAL COLLEGE AND HOSPITAL, BHUBANESWAR
&
EAST COAST RAILWAY (E. Co. Rly.) BHUBANESWAR
FOR TREATMENT OF THE RAILWAY BENEFICIARIES**

Ministry of Railways, Govt. of India (Railway Board) vide letter no. 2014/H-1/11/10 dated 12.03.2014 has accorded the sanction for 6th term extension to the recognition of Hi-Tech Medical College & Hospital, Bhubaneswar (overall 7th term) for a period of one year from 12.03.14 to 11.03.2015 in the specialties with ICU services i.e. (i) ICU services (ii) Trauma Care & Accident cases (iii) Gastrology and Gastro Surgery (iv) Paediatric surgery (v) Haematology (vi) Nephrology (vii) Emergency cases of any nature, on bill system of payment as per CGHS/Non-NABH/BBS rates or hospital tariff, whichever is lower and for items not covered in CGHS-BBS list, as per nearest city rates of CGHS/Non-NABH/Patna rates or Delhi rates whichever is lower. In case of items not covered under CGHS/BBS/Patna/Delhi, as per AIIMS rates and finally, if not available in any of the rate list of CGHS/BBS/Patna/Delhi and AIIMS, at hospital tariff with 10% discount thereon. Further, a discount of 5% may also be provided on Drugs & Disposables. Upward revision of rates during this period will not be considered.

Now, with the concurrence of FA&CAO/ECorly and with the sanction of General Manager/ECorly, the currency of such recognition is further extended for another period of one year from 12.03.2015 to 11.03.2016 (7th term extension-overall 8th term) on the terms & conditions of the expired contract. **The said extension of tie-up with the hospital is on new CGHS-BBS-2014-Non-NABH tariff** or hospital tariff, whichever is less and for items not covered in CGHS-BBS list, as per nearest city rates of CGHS/Non-NABH/Patna rates or Delhi rates whichever is lower. In case of items not covered under CGHS/BBS/Patna/Delhi, as per AIIMS rates and finally, if not available in any of the rate list of CGHS/BBS/Patna/Delhi and AIIMS, at hospital tariff with 10% discount thereon. Further, a discount of 5% may also be provided on Drugs & Disposables. Upward revision of rates during this period will not be considered.

Accordingly, the following MOU is made this day between the two parties i.e. East Coast Railway & Hi-Tech Medical College and Hospital, Bhubaneswar.

1. Patients will be referred to Hi-Tech Medical College & Hospital, Bhubaneswar with a referral letter, signed by the competent authority i.e. Chief Medical Superintendents of the Divisional Railway Hospitals of Visakhapatnam, Khurda Road, Sambalpur & Medical Director of Central Hospital/ Bhubaneswar for Mancheswar & Chandrasekharapur complexes at Headquarters. The copy of the specimen signature of the competent authorities and other authorized signatories nominated by them shall be submitted to Hi-Tech Medical College & Hospital, Bhubaneswar.
2. The Medical facility shall be extended only to the employees and their dependent family members and RELHS card Holders on production of referral letter, issued by the authorized medical officer only. This would be applicable for one time referral and shall be valid for seven days only. After discharge, if revisit/ review in OPD are required, a new referral letter has to be issued by the competent authority.
3. In case of 'emergency', the patient of East Coast Railway shall be admitted in Hi-Tech Medical College & Hospital, Bhubaneswar subject to production of Identity Card/Medical Card, RELHS Card with intimation to the referring authority over telephone and fax by the authority of Hi-Tech Medical College & Hospital, Bhubaneswar. The referring authority, after verification, shall issue the referral letter within three days from the date of admission. Otherwise, the patient shall be treated as a non-referral case, which would lead to admission on cash payment by the patient. In such cases, the Railway shall not be liable for the expenditure. **'Emergency' shall mean any condition or symptom resulting from any cause, arising suddenly and if not treated at the early convenience, be detrimental to the health of the patient or will jeopardize the life of the patient.**

4. **STATUTORY REQUIREMENT:** As the system of tie-up with the private hospitals has been made for tertiary care, mostly not available in Railway Hospitals, it will be improper on the part of Private Recognized Hospital to deny admission of a referred case or emergency case of the Railways. Being an important issue, it shall be binding on the part of Hi-Tech Medical College & Hospital, Bhubaneswar to accept all referred cases (as per Clause 1 above) as well as emergency cases (as per Clause 3 above) for admission & treatment. At no time, admission should be refused or denied. Failure on the part of hospital to fulfill this statutory requirement, fine shall be imposed which would be equal to the amount of treatment of the said case (patient) in other hospital. The amount of fine so arrived at & imposed shall be deducted from the pending bills of Hi-Tech Medical College & Hospital, Bhubaneswar due for payment.
5. The referral letter shall clearly indicate the category of accommodation as per the eligibility of the employee and Hi-Tech Medical College & Hospital, Bhubaneswar shall give the same type of accommodation. If special accommodation is required to be provided to the patient in view of the medical condition, the same should be confirmed with the referral authority over telephone/fax, numbers of which shall be made available in the referral letter & the Hi-Tech Medical College & Hospital, Bhubaneswar should certify the same in the essentiality certificate while submitting the final bill for payment. The eligibility criteria for accommodation, as per CGHS guidelines, are given hereunder:

| Sl. No. | Basic Pay (without the inclusion of Grade Pay) | Entitlement | Rate (in ₹) |
|---------|--|-------------------|-------------|
| 1 | Upto ₹13950/- | General Ward | 1000 / day |
| 2 | Between ₹13951/- and ₹19530/- | Semi-Private Ward | 2000 / day |
| 3 | ₹19540/- and above | Private Ward | 3000 / day |

- (i) The above type of accommodation is also to be provided to the RELHS Card holders as per the status of the card holder mentioned in the RELHS Card.
- (ii) Employee/beneficiaries can avail lower type of accommodation if same type is not available at the time of admission. If the employee/beneficiaries opt for any higher accommodation, the additional charges have to be borne by the individuals, **which is to be collected from the patient before discharge. The undertaking for payment of difference of cost should be taken from the Railway beneficiary requesting higher accommodation.**
- (iii) The ICU/Semi-ICU/NICU/POCU/Causality facility service shall not be treated as the category of accommodation.
- (iv) Whenever a patient, staying in the paying room is shifted to intensive care unit, the room has to be vacated as the Railway shall pay for only one Room at any given point of time.
6. The Package Rates are for Semi-Private Ward. If a beneficiary is entitled for General Ward, there will be decrease of 10% in the rates; for private ward entitlement, there will be an increase of 15%. However, the rates shall be same for investigation irrespective of entitlement, whether the patient is admitted or not and test per se does not require admission to hospital.
7. **Where applicable as per present sanction, the Medical expenditure bill shall be prepared on case-wise basis on CGHS/BBS/Non-NABH rates on package rates.**
- "Package Rate" shall mean and include lump sum cost of in-patient treatment/day-care/ diagnostic procedure for which a CGHS beneficiary had been permitted by the competent authority or for treatment under emergency from the time of admission to the time of discharge, including (but not limited to)- (i) Registration Charges, (ii) Admission charges, (iii) Accommodation charges including patient's Diet, (iv) Operation charges (v) Injection charges (vi) Dressing charges (vii) Doctor/Consultant visit charges (viii) ICU/ICCU Charges (ix) Monitoring Charges (x) Transfusion Charges (xi) Anesthesia Charges (xii) Operation Theater Charges (xiii) Procedural charges/Surgeon's fee (xiv) Cost of surgical disposables and all sundries used during hospitalization (xv) Cost of medicines (xvi) Related routine and essential investigations (xvii) Physiotherapy charges etc. (xviii) Nursing care charges etc.

- Cost of implants/stents/grafts is reimbursable in addition to package rates as per CGHS ceiling rates or as per actual, whichever is lower. **Ceiling Rates of CGHS are as per O.M. No. 1002/2006/CGHS(R&H)/CGHS(P) dated 7.02.2013, 21.02.2013 & 29.04.2014 and O.M. No. 12034/02/2014/Misc./-CGHS D.III dated 22.07.2014 issued by the Ministry of Health & Family Welfare, Govt. of India.**
- Treatment charges for new born baby are separately reimbursable in addition to delivery charges for mother.
- Hospitals/diagnostic centers empanelled under CGHS shall not charge more than the package rate(s).
- **Expenses on toiletries, sanitary napkins, talcum powder, mouth fresheners, cosmetics, telephone bills etc are not reimbursable and are not included in package rates.**
- Package rates envisage up to a maximum duration of indoor treatment as follows:

No additional charge on account of extended period of stay shall be allowed if that extension is due to infection on the consequences of surgical procedure or due to any improper procedure and is not justified.

8. Rate revision for Coronary Angioplasty & Coronary Angioplasty with Balloon vide Ministry of Health & Family Welfare, Govt. of India I. Office Memorandum F.No.Misc.1002/2006/CGHS(R&H)/CGHS(P) dated 07.02.2013 & rate revision for various Stents vide Ministry of Health & Family Welfare, Govt. of India Office Memorandum F.No.Misc.1002/2006/CGHS(R&H)/CGHS(P) dated 21.02.2013 and 29.04.2014 are to be strictly followed while making case-related bills to be presented by Hi-Tech Medical College & Hospital, Bhubaneswar to the referral authorities of East Coast Railway for passing payment.
9. Treatment procedure for which package tariff is available, the billing is to be made on package rate even if it is not mentioned in the referral letter. Where the package CGHS rate is not available, it should be billed on CGHS individual rates. In case there is no CGHS prescribed rate available for any procedure/investigation/ category, then in terms of O.M. No. S.11011/23/2009-CGHS D.II/Hospital Cell (Part IX), dtd.30.09.2011 issued by Ministry of Health & Family Welfare, Govt. of India, CGHS rates of the nearest city (Patna in this case) or rates applicable under CGHS/Delhi, whichever is lower, shall be applicable. In case of items not covered under CGHS/BBS/Patna/Delhi, as per AIIMS rates and finally, if not available in any of the rate list of CGHS/BBS/Patna/Delhi and AIIMS, at hospital tariff with 10% discount thereon.
10. Normally, treatment in higher category of accommodation than the entitled category is not permissible. However, in case of an emergency, when the entitled category accommodation is not available, admission in the immediate higher category may be allowed till the entitled category accommodation becomes available. However, if Hi-Tech Medical College & Hospital, Bhubaneswar does not have the ward as per entitlement of the Railway beneficiary, then the hospital can only bill as per entitlement of the beneficiary even though the treatment was given in higher type of ward. The bills should be raised to the referring authority along with Discharge Summary Certificate, Essentiality Certificate and other relevant papers in duplicate, along with the copy of the referral letter produced at the time of admission. It shall be prepared on case-wise basis with itemized entries including different head of expenditure.
11. If procedure is delayed on the part of Hi-Tech Medical College & Hospital, Bhubaneswar for any reason whatsoever, Railway shall not bear any charges of additional stay and treatment provided to the patient.

12. Any treatment procedure provided beyond the CGHS package has to be mentioned clearly along with item-wise entry. In this situation, essentiality of the procedure, prescription of doctor, cash memo in support of purchase of medicines and other items purchased/supplied during the course of treatment shall be submitted in original while submitting the final bill. No Miscellaneous type of expenditure shall be included. Hi-Tech Medical College & Hospital, Bhubaneswar shall give medicines, Disposables, and any other items required for treatment to the patient and they shall include the same in the final bill/package bill. Patients shall not be asked to purchase the medicines or any essential item required for treatment from outside.
13. If one or more minor procedure form part of a major treatment procedure, then package charge would be admissible for major procedure and only 50% of the charges for minor procedures.
14. **All investigations regarding fitness for the surgery shall be done prior to admission for any elective procedure and are part of package.**
15. The ceiling regarding cost of implants/appliances, not available in the CGHS Rate-list, shall be charged as per actual. For implants / appliances, the hospital authority shall produce invoice/bill as proof of rate charged for the same. The Referral Authority while finalizing the bills of the hospital for payment shall certify the rate-reasonability.
16. If a patient is discharged before the stipulated package period and if complications reoccur before the end of the package period, the patient shall be treated free of cost in Hi-Tech Medical College & Hospital, Bhubaneswar. At no time, the patient or his/her attendant/family member shall be asked to pay any amount during that period.
17. Number of consultations conducted/advised by the specialist doctor during the hospitalization shall be clearly mentioned in the bill, duly countersigned by the Medical Superintendent of Hi-Tech Medical College & Hospital, Bhubaneswar.
18. Fees towards Casualty, OPD Registration & Consultation, Investigation, etc. if any, shall be included in the final bill submitted for payment and shall not be charged separately to the patient.
19. **The requirement of Blood for the patients during CA/PTCA/CABG shall be met by Hi-Tech Medical College & Hospital, Bhubaneswar with replacement by patients' relatives and without any additional cost.**
20. The medicines given to the patients are to be supported by invoice (to be endorsed with the bill) and all investigations carried out during the period of hospitalization/treatment are to be certified by the Medical Superintendent of Hi-Tech Medical College & Hospital, Bhubaneswar.
21. In no case, the Pharmacy & other items shall be charged at a higher rate than the printed MRP. Wherever applicable, institutional discount on price should be given. This should be strictly taken care of while making bills to be presented for payment.
22. Further, as per CGHS guidelines, a hospital/diagnostic centre empanelled under CGHS, whose rates for treatment procedure/test are lower than CGHS prescribed rates, shall charge as per actual (not more than rates for non-CGHS beneficiary). In other words, if rates of Hi-Tech Medical College & Hospital, Bhubaneswar are lower than CGHS-BBS-2014 rates for any particular treatment procedure/test, then Hi-Tech Medical College & Hospital's rates shall be charged for that particular case of Railway. Similar is the case with Accommodation. The prescribed rates for accommodation under CGHS are → General Ward- ₹1000/- per day, Semi-Private Ward- ₹2000/- per day, Private Ward- ₹3000/- per day. If the rates of accommodation charges of Hi-Tech Medical College & Hospital, Bhubaneswar are lower than these prescribed rates of CGHS, then it shall be charged as per rates of Hi-Tech Medical College & Hospital, Bhubaneswar. The authority of Hi-Tech Medical College & Hospital, Bhubaneswar shall provide one copy of the current rate-chart of the hospital, duly certified by its authorized signatory, to the Railway for circulation amongst all the bill passing units of the Railway.
23. Hi-Tech Medical College & Hospital, Bhubaneswar shall raise the final bill to the referring authority from where referral letter was issued, who shall, so far as possible, arrange payment within 60 days from the receipt of the bills.
24. All the facilities/treatment shall be extended by Hi-Tech Medical College & Hospital, Bhubaneswar to the patients referred by E.Co.Rly. on credit basis.

3. Stipulations regarding presentation of bills by the hospital and its payment by Railway shall be as under:

- **Submission of bills by the hospital for Railway patients discharged from -**
1st day to 15th day of the month – by 25th day of that month
16th day to 30th/31st day of the month – by 10th day of the following month
- **Payment of bills by the Railway – 60 days from the receipt if the bills are in order**

Any bill found to be inadmissible during the course of scrutinization shall be intimated to the authority of Hi-Tech Medical College & Hospital, Bhubaneswar within at least 10 days from receipt of the bills. If no satisfactory explanation is received within 10 days, the disallowed amount shall be deducted from the claimed amount and the admissible amount shall be paid after sanction of the competent authority. In case, any amount found to be disallowed, East Coast Railway shall provide details of payment and deduction to the authority of Hi-Tech Medical College & Hospital, Bhubaneswar while making payment. The disallowed bills will not be entertained in future.

26. As per RBI guidelines, the payment shall be made by the referring authorities through NEFT/RTGS mode of fund transfer to Hi-Tech Medical College & Hospital, Bhubaneswar, after due scrutinization and sanction of the competent authority, at least within 60 days of receipt of bills. For facilitating the NEFT/RTGS mode of fund transfer, the authority of Hi-Tech Medical College & Hospital, Bhubaneswar shall furnish the revised mandate form showing the IFSC Code of their banker.
27. The bills shall not include the Telephone charges, TV charges, cost of Cosmetics/Toiletries/ Tonics/Food items/other Medicines advertised in mass media. If a patient wants to avail these facilities/items, the cost thereof shall be recovered personally from him/her.
28. **Prevalent CGHS rates of Bhubaneswar for Non-NABH category are allowed. Billing shall be as per provisions contained in Para-6 to 27 of this MoU. No alteration in the approved tariff during the MoU period is allowed unless/until the same is revised by CGHS/Govt. of India.**
29. **For any material/additional procedure/investigation other than the condition for which the patient was initially permitted/referred, would require the permission of the referral authority except under emergency.**
30. **Any Major treatment shall not be carried out without prior approval of the referral authority. During the course of treatment for the following cases, the authority of Hi-Tech Medical College & Hospital, Bhubaneswar shall take approval of the referral authority:**
- a. Any major treatment procedure, which is not reflected in the referral letter but is felt essential for treatment of the patient. The essentiality and rate-reasonableness of the same has to be certified by Referral Authority.
 - b. If in any case, the initial treatment procedure/bill amount exceeds ₹1.00 lakh and for every ₹1.00 lakh thereafter for the same case.
 - c. For an admitted case, stay in the hospital for more than 10 days and subsequently, for every 10 days' stay thereafter for the same treatment. Justification for the same shall be furnished by Hi-Tech Medical College & Hospital, Bhubaneswar to the referral authority.
 - d. Any special investigation felt essential for the patient during hospitalization, which is not reflected in the referral letter and also not available in Hi-Tech Medical College & Hospital, Bhubaneswar but required to be done in any outside authorized agency at a higher cost than the contracted CGHS rates. The rate reasonability of such investigation has to be certified by the referral authority.
- For each case under a to d above, the Referral Authority of Railway (MD/CMS in-charge of the Railway Hospitals) shall ensure that facilities provided /requirements were the minimum, which were essential for the patient's treatment.**

31. Details of investigation carried out during the treatment shall be mentioned in the discharge summary/OPD ticket by the treating doctor.

32. Use of Stents/Grafts/Implants – Procedural details in soft copy shall invariably be submitted along with bills for proper documentation of the procedures conducted on the patients, if any. The same procedure shall apply for Angiogram also. **The logo/sticker/outer pouch of the stent/implant shall be affixed on the indoor case paper of the patient and the brand/size & specific number of the stent shall be mentioned on the bill to be submitted to Railway for payment.**
33. **As soon as the condition of the patient becomes stable, he/she shall be referred back to the Railway Hospital from where referred for further management. The period of admission shall be the barest for essential period only.**
34. **Review report of the admitted Railway patients shall be sent by Hi-Tech Medical College & Hospital, Bhubaneswar every 10 days to the referral authorities of the Railway.**
35. The medicines as prescribed at the time of discharge of the patient from Hi-Tech Medical College & Hospital, Bhubaneswar shall be for three days only & it shall be generic. After that, the same shall be supplied by the Railway hospital on patient's reporting.
36. Any correspondence and queries about the patient towards treatment shall be communicated to the concerned referral authorities.
37. **Hi-Tech Medical College & Hospital, Bhubaneswar shall ensure that Railway patients referred to the hospital are given timely & satisfactory treatment by the hospital.**
38. **Hi-Tech Medical College & Hospital, Bhubaneswar shall not undertake treatment of referred cases in specialties other than those for which the hospital is recognized. But, in emergencies, it shall provide necessary treatment to stabilize the patient and transport the patient safely to nearest recognized hospital under intimation to the local Railway referral authorities. However, in such cases, the hospital shall charge as per the CGHS rates only for the treatment so provided.**
39. When a Railway patient is admitted in Hi-Tech Medical College & Hospital, Bhubaneswar, the Railway doctor, if required, shall be allowed to visit the hospital at any time to attend to the patient's condition.
40. Any Consequent procedural changes made from time to time shall be done by the East Coast Railway in due consultation with the authority of Hi-Tech Medical College & Hospital, Bhubaneswar.
41. Chief Medical Director, East Coast Railway, Bhubaneswar agrees to the fact that the decision of Hi-Tech Medical College & Hospital, Bhubaneswar will be final with respect to all matters of treatment. The referral authority shall certify the same before the bills are sent to the respective Accounts Department.
42. Pending bills if any shall be cleared up within the stipulated period. In case of any dispute arises, the same shall be settled amicably between Railway and the authorities of Hi-Tech Medical College & Hospital, Bhubaneswar. If such disputes could not be resolved amicably, either party may refer such disputes to Arbitration Tribunal, which shall be guided as per IRS-GCC-2014 (Clause No. 63 to 64) and extant Railway Board's instructions.
43. As per guidelines of Railway Board, the bills raised by private Recognized Hospitals for treatment of Railway beneficiaries are liable for Income Tax and other levies as per instructions from the Govt. of India.
44. **Hi-Tech Medical College & Hospital, Bhubaneswar shall provide to & fro free Ambulance services, as per availability, to East Coast Railway beneficiaries from Central Hospital at Mancheswar, Bhubaneswar and from Railway Station, Bhubaneswar for emergency transportation of patients and referrals for OPD treatment, Indoor treatment, Dental treatment and for Pathological/Radiological Investigations/any other medical treatment.**
45. **Hi-Tech Medical College & Hospital, Bhubaneswar is liable to pay any claim made against the Railway towards damages/compensations or any claim arising out of the treatment provided during the period of hospitalization at Hi-Tech Medical College & Hospital.**

46. Duties and Responsibilities of the Empanelled Hospitals – It shall be the duty and responsibility of the empanelled hospital at all times to obtain, maintain and sustain the valid registration, recognition and high quality and standards of its services and healthcare and to have all statutory/mandatory licenses, permits or approvals of the concerned authorities under or as per existing laws.
47. Hi-Tech Medical College & Hospital, Bhubaneswar is responsible for and obliged to conduct all contracted activities in accordance with Agreement using state-of-the-art methods and economic principles and exercising all means available to achieve the performance specified in the Agreement. It is obliged to act within its own authority and abide by the directives issued by the CGHS. It is also responsible for managing the activities of its personnel and shall hold itself responsible for their misdemeanors, negligence, misconduct or deficiency in services, if any.
48. All the appropriate procedures, medico-legal formalities and code of medical ethics as required under the local laws and the Railway rules shall be taken care of by Hi-Tech Medical College & Hospital, Bhubaneswar.
49. After termination/expiry of this MOU, Hi-Tech Medical College & Hospital, Bhubaneswar shall continue extending its services to the admitted Railway patients till their discharge. The bills shall be raised to the referral authority, which will pay the dues as per rates mentioned in the MOU.
50. For the purpose of better co-ordination in regard to the tie-up facility, Hi-Tech Medical College & Hospital, Bhubaneswar shall nominate a NODAL OFFICER who will be solely responsible for overseeing the referral cases. East Coast Railway shall also nominate a NODAL OFFICER each at the levels of Central Hospital/BBS and at the three Divisional Railway Hospitals of Waltair, Khurda Road and Sambalpur. The name, designation, contact number, e-mail address of such NODAL OFFICERS shall be made available at all ends i.e. NODAL OFFICER of Hi-Tech Medical College & Hospital, Bhubaneswar with the NODAL OFFICERS of East Coast Railway at Central Hospital/BBS and at the three Divisional Railway Hospitals of Waltair, Khurda Road & Sambalpur and Vice-versa. Overall co-ordination will be done at the level of Chief Medical Director, East Coast Railway from his office at 2nd Floor, North Block, Rail Sadan, Chandrasekharpur, Bhubaneswar-17.
51. This agreement shall be in effect for a period of one year from 12.03.2015 to 11.03.2016 and may be extended for such further periods and such terms as may be agreed upon, in writing between the parties.
